- 3. How important is the nonprofit sector relative to your broader policy agenda? Please explain.

LONDON - FANSHAWE

Teresa ARMSTRONG, Ontario NDP

1. Being on the board of LUSO has given me firsthand experience of the importance of nonprofits. Helping promote multiculturalism, inclusiveness, well-being and prosperity in our community remains important to me. I was also one of the first chair persons for the Argyle Community Resource Center. Again, this provided firsthand experience in the sector. Being a part of nonprofits has given me experience and knowledge to understand their influence within the community.

The strength and value of not-for-profits are sometimes dismissed and regularly misheard. However, they play a very important role within our communities. Not only I, but also my friend and NDP Leader Andrea Horwath are very grassroots' oriented. Andrea received the Woman of the Year Award in Public Affairs from the Hamilton Status of Women Committee, in recognition of her work in the community. She was also involved with social housing, to the extent that she was awarded the Graham Emslie Award for Community Development in Housing by the Canadian Housing and Renewal Association.

So you can be sure that when we say we will listen to your expertise and advice, that as an MPP my door will be open to listen to, and work with you, it isn't platitudes or rhetoric, it is being true to my roots.

New Democrats in particular want to support and strengthen not-for-profit housing, childcare, and long term care for seniors in this province. There is a desperate need for all three and we cannot wait for the private sector to see such ventures as profitable because people are in need now! Further, private sector businesses always have to feed the profit margins, which invariable means cutting corners. The not-for-profit sector is the ideal service provider for such services.

- 2. The primary focus of our election platform is on making life more affordable, and helping people get back to work. Wouldn't it be great if no one had to depend on foodbanks? We need to support our nonprofits, but we also need to take the first steps to reduce the dependency and need for certain types of not-for-profit and charitable organizations. However, there will always be an important role for the broader not-for-profit sector to play in our province and I will continue to help maintain the existing financial support. Each not-for-profit sub-sector has specific needs and service targets. There will be greater financial investments, specifically in the areas of childcare and long term care for seniors.
- **3.** Needless to say, the nonprofit sector plays a vital part within our society. Nonprofit organizations share similar goals to the political goals of the New Democratic Party- whether it be awareness, professional development, aid, or working towards a sustainable environment. Not-for-profits, like New Democrats, put the good of the people or cause they serve above the drive to reap monetary gain.



I would like to share two agendas within our policy platform that are relevant to the not-for-profit sector; the first being housing. It saddens me to hear that recently a United Way report stated around 40 per cent of tenants are living in poverty, in areas that are bug infested and neglected. These tenants are left with no recourse as they are already in circumstances that allow them little for necessities such as food and utilities, let alone the opportunity and ability to locate better places to live. Cheri DiNovo, NDP MPP, and Housing critic, states that Ontario has one of the worst affordable housing records in the country, proposing 'the need for landlord licensing, inclusionary zoning, better tenants' rights and setting targets for increasing affordable housing is urgent'. The last co-operative housing in our community which was built with the support of provincial funds was nearly two decades ago under the only NDP government Ontario ever elected, during the worst recession in two generations, because of the value New Democrats see in not-for-profit housing.

Second, I think it is important to mention homecare. As of right now the NDP is the only party which is committed to investing in homecare services to help relieve pressure on frontline healthcare. We know that keeping a senior, who could be cared for at home, in a hospital bed costs \$1200 a day. For that same dollar value, utilizing the not-for-profit sector, we could provide homecare for 12 seniors. We are also concerned with the quality of care seniors are getting in long term care beds as a result of "competitive bidding" processes. The lowest bid is not the best bid when it comes to our seniors. It leads to poor quality food, little personal care or nursing attention. Yet 1 in 4 seniors in a long term bed could be cared for at home, if access to homecare services was available. This is not acceptable.

The NDP wants to create a better community by making it more accessible and sustainable. We must fight poverty and give opportunity to our children. The not-for-profit sector is vital to our broader policy because it is *built* into it. I want to ensure better living conditions through healthcare, housing, childcare, and what better place to start than to work with organizations who deal with these issues first hand.

Dave DURNIN, Freedom Party of Ontario

And like my federal New Democrat colleagues, I support tax legislation to increase the incentive for Canadians to support charitable and non-profits. I encourage you to take a look at our Plan For Affordable Change for details on investments in housing, social benefits and other programs that will have a direct impact on the work done by many of London's charities.
- **2.** Many of our announced ideas, like removing the HST on essentials, support for housing, a transit fare freeze, and improvements to social assistance will have a direct financial impact helping nonprofits. We will work to enhance and stabilize long term funding so Ontario charities are able to better plan for the future and improve the consistent levels of service they provide.
- **3.** New Democrats like myself recognize that the volunteer sector not only enriches the lives of thousands of Londoners, but also has a huge economic impact worth hundreds of millions of dollars every year in our local community.

As more people become involved, our communities will continue to thrive and prosper. We have spent a great deal of time in this campaign talking about jobs, and the non-profit sector is one of the province's largest employers. We are well aware of that as we craft our policies relating to everything from early childhood education, to the arts, to the environment, to housing, to social services, to health care and a multitude of other areas.

1. Ontario Liberals are committed to maintaining and building a strong and diverse not-for-profit sector in the province of Ontario. That's why we launched the Partnership Project, the first-ever comprehensive consultation process with the sector to strengthen its partnership with the government. After year-long discussions with the sector in rural and urban Ontario, the comprehensive Partnership Project (http://www.citizenship.gov.on.ca/images/pp/PP report.jpg) report and plan was released in April 2011. Premier McGuinty accepted the plan's recommendations as the vision for our continued partnership with the not-for-profit sector.

Ontario Liberals will continue to implement the commitments made in the Partnership Project report and will work to enhance our collaborative relationship with the not-for-profit sector.

Already, our plan is getting results:

- We established The Partnership Project Office to help co-ordinate and support advocacy efforts with government.
- We provided \$2M to promote innovation and build capacity in the sector in areas such as coordinated service delivery, volunteer management and training.
- We brought Ontario's private, public and not-for-profit sectors together through the Social Innovation Summit to advance projects that support social innovation and enterprise.
- Ontario Liberals initiated a government-wide Not-for-profit Open-For-Business initiative, to reduce administrative and regulatory burdens.
- We are hosting an international volunteerism forum in December 2011. The forum will look to the future of volunteerism in Ontario and the best methods to support Ontario's volunteers.
- We expanded Infrastructure Ontario's loan program to provide access to capital for community health and social services hubs, aboriginal health access centres and non-profit sports and recreation organizations in Ontario.
- The Youth Opportunities Program and the Youth and Philanthropy Initiative have been launched to encourage Ontario's youth to contribute to their communities.

In addition to the Partnership Project, Ontario Liberals have:

- Launched more than 70 projects to build the capacity of non-profit organizations.
- Recognized the sector's human resources concerns and pledged to provide graduates with a oneyear grace period on their OSAP loans in order to encourage a new generation of Ontarians to join the not-for-profit sector.
- Updated the Not-for-Profit Corporations Act for the first time in 50 years to provide not-for-profits with a modern legal framework and allow not-for-profits to engage in new revenue-generating activities to support the good work that they do.
- Recognized more than 67,000 volunteers at more than 300 Volunteer Service Awards ceremonies across Ontario.

Ontario Liberals are committed to continuing and expanding our record of investing in the not-for-profit sector, supporting social innovation, reducing legislative and regulatory barriers to financing, and promoting volunteerism. - **2.** Ontario Liberals recognize that not-for-profits work hard to operate on tight budgets while delivering critical services to our families and our communities. We've made significant investments in communities across Ontario. Unlike, the Harris-Hudak PCs who cut social services and supports for not-for-profits, we know that this sector builds communities and makes our families prosper. That's why we are working with the sector to find new ways of supporting its work, while exploring innovative new solutions to enhance the sector's access to revenue and capital. We are committed to continuing with the Partnership Project plan to devise new solutions for funding flexibility.
- **3.** The not-for-profit sector is an irreplaceable building block of our communities, our economy and an employer of more than 1 million Ontarians.

The Ontario Liberals are the only party to recognize the sector as an equal partner by building a strong relationship with the sector, based on concrete action and respect, to improve coordination and enhance investments in our communities.

We believe that one way to improve productivity is to open up the provision of government services to new forms of competition. 1. The strength and value of not-for-profits are sometimes dismissed and regularly misheard. However, they play a very important role within our communities. Our leader, Andrea Horwath received the Woman of the Year Award in Public Affairs from the Hamilton Status of Women



Committee, in recognition of her work in the community. She was also involved with social housing, to the extent that she was awarded the Graham Emslie Award for Community Development in Housing by the Canadian Housing and Renewal Association. For that reason alone you can be assured that we understand the importance and value of non profits and charities to the community.

New Democrats in particular want to support and strengthen not-for-profit housing, childcare, and long term care for seniors in this province. There is a desperate need for all three and we cannot wait for the private sector to see such ventures as profitable because people are in need now! Further, private sector businesses always have to feed the profit margins, which invariable means cutting corners. The not-for-profit sector is the ideal service provider for such services.

- 2. The primary focus of our election platform is on making life more affordable, and helping people get back to work. Wouldn't it be great if no one had to depend on foodbanks? We need to support our nonprofits, but we also need to take the first steps to reduce the dependency and need for certain types of not-for-profit and charitable organizations. However, there will always be an important role for the broader not-for-profit sector to play in our province and I will continue to help maintain the existing financial support. Each not-for-profit sub-sector has specific needs and service targets. There will be greater financial investments, specifically in the areas of childcare and long term care for seniors.
- **3.** Needless to say, the nonprofit sector plays a vital part within our society. Nonprofit organizations share similar goals to the political goals of the New Democratic Party- whether it be awareness, professional development, aid, or working towards a sustainable environment. Not-for-profits, like New Democrats, put the good of the people or cause they serve above the drive to reap monetary gain.

I would like to share two agendas within our policy platform that are relevant to the not-for-profit sector; the first being housing. It saddens me to hear that recently a United Way report stated around 40 per cent of tenants are living in poverty, in areas that are bug infested and neglected. These tenants are left with no recourse as they are already in circumstances that allow them little for necessities such as food and utilities, let alone the opportunity and ability to locate better places to live. Cheri DiNovo, NDP MPP, and Housing critic, states that Ontario has one of the worst affordable housing records in the country, proposing 'the need for landlord licensing, inclusionary zoning, better tenants' rights and setting targets for increasing affordable housing is urgent'. The last co-operative housing in our community which was built with the support of provincial funds was nearly two decades ago under the only NDP government Ontario ever elected, during the worst recession in two generations, because of the value New Democrats see in not-for-profit housing.

Second, I think it is important to mention homecare. As of right now the NDP is the only party which is committed to investing in homecare services to help relieve pressure on frontline healthcare. We know that keeping a senior, who could be cared for at home, in a hospital bed costs \$1200 a day. For that same dollar value, utilizing the not-for-profit sector, we could provide homecare for 12 seniors. We are also concerned with the quality of care seniors are getting in long term care beds as a result of "competitive bidding" processes. The lowest bid is not the best bid when it comes to our seniors. It



leads to poor quality food, little personal care or nursing attention. Yet 1 in 4 seniors in a long term bed could be cared for at home, if access to homecare services was available. This is not acceptable.

The NDP wants to create a better community by making it more accessible and sustainable. We must fight poverty and give opportunity to our children. The not-for-profit sector is vital to our broader policy because it is *built* into it. I want to ensure better living conditions through healthcare, housing, childcare, and what better place to start than to work with organizations who deal with these issues first hand.
